ORDINANCE NO. 22-10

**AN ORDINANCE WAIVING THE PARK REGULATIONS AT CERTAIN VILLAGE PARKS
ON JULY 2, 2022, JULY 15 and 16, 2022 FOR THE CHATHAM JAYCEES 4TH OF JULY
EVENT, AND SWEETCORN FESTIVAL**

WHEREAS, the Village of Chatham (hereinafter “Village”), Sangamon County, State of Illinois, is a duly organized and existing Village created under the provisions of the laws of the State of Illinois, and is now operating under the provisions of the Illinois Municipal Code; and

WHEREAS, the Village previously enacted Ordinance No. 77-16, now codified in Chapter 94 of the Village Code, regulating the use of the Chatham Village Park and, by implication, all other public parks and space in Chatham; and

WHEREAS, Section 94.03 of the Village Code states it shall be unlawful for any person to possess or consume alcoholic liquors in a Village park, unless otherwise provided; and

WHEREAS, Section 94.05 provides the Village Board may, by formal action, grant specific exceptions to the Park regulations in Chapter 94 when in the best interests of the residents of the Village;

WHEREAS, the Village has received an application for the Jaycees to host a July 4th event to take place at Community Park on July 2, 2022; and

WHEREAS, the Village has received an application for the Jaycees to host a July 15th and July 16th event to take place at Community Park on July 15th and July 16th, 2022; and

WHEREAS, at such events, it is requested that alcohol be served and therefore a waiver is necessary to allow alcohol at the event; and

WHEREAS, the Corporate Authorities of the Village believe it is in the best interest of the Village to allow alcoholic beverages at Community Park as part of these events on July 2, July 15, and 16, 2022, in accordance with the regulations set forth in this Ordinance.

NOW, THEREFORE, BE IT ORDAINED by the President and Board of Trustees of the Village of Chatham, County of Sangamon, as follows:

Section 1. Recitals. The foregoing recitals shall be and are hereby incorporated into and made a part of this Ordinance as if fully set forth in this Section 1.

Section 2. Waiver of Rules of Community Park.

- i) The Village hereby waives all rules prohibiting the sale, possession and consumption of alcohol as well as all Park Curfew Rules on July 2, 2022, at the Chatham Community Park for the July 4th event hosted by the Jaycees.
- ii) The Village hereby waives all rules prohibiting the sale, possession and consumption of alcohol as well as all Park Curfew Rules on July 15th, and 16th 2022, at the Chatham Community Park for the event hosted by the Jaycees.

Section 3. Powers of Liquor Commissioner. The Village President, as liquor commissioner, is hereby authorized to promulgate rules and regulations addressing the temporary relaxation of certain provisions for outdoor service. The Village President is hereby authorized to allow establishments to temporarily reduce required parking to open space for outdoor service, including closing public parking directly adjacent to a licensed premise. The Village President is hereby authorized to impose discipline upon a licensed establishment in violation of the Village Code or the rules and regulations including, but not limited to, revocation of the temporary privileges granted herein. Notwithstanding the foregoing, the Village President may only expand rights of licensees to the extent provided by Illinois law, Illinois Executive Orders, Regulations promulgated by the Illinois Liquor Control Commission, Restore Illinois operating guidance by the Illinois Department of Commerce and Economic Opportunity, the Illinois Department of Public Health, or the like, and the Village president cannot expand rights greater than those allowed by the State of Illinois and cannot promulgate rules that directly conflict with the Village Ordinances not suspended herein.

Section 4. Severability. In the event a court of competent jurisdiction finds this ordinance or any provision hereof to be invalid or unenforceable as applied, such finding shall not affect the validity of the remaining provisions of this ordinance and the application thereof to the greatest extent permitted by law.


Section 5. Repeal and Savings Clause. All ordinances or parts of ordinances in conflict herewith are hereby repealed; provided, however, that nothing herein contained shall affect any rights, actions, or causes of action which shall have accrued to the Village of Chatham prior to the effective date of this ordinance.

Section 6. Effective Date. This Ordinance shall be in full force and effect from and after its passage and approval as provided by law.
