AN ORDINANCE ACCEPTING A BID FOR BORING UNDERGROUND UTILITIES IN THE VILLAGE OF CHATHAM

WHEREAS, the Village of Chatham ("Village") is an Illinois Municipal Corporation existing and operating under the Illinois Municipal Code and the laws of the State of Illinois; and

WHEREAS, the Village requested bids for a three phase boring project for underground utilities within the Village of Chatham; and

WHEREAS, the Village solicited bids in accordance with Illinois law for proposals from companies willing and able to provide the services requested, and the Village opened all bids on September 19, 2022; and,

WHEREAS, the bid documents made clear that the Village reserved the right to accept or reject any and/or all parts of the bid; and,

WHEREAS, the bid documents requested a per foot boring cost because, at the time of bidding, due to undulations of the ground on the proposed path, the exact footage of the project could not be determined; and,

WHEREAS, the Village received three responsive bids; and,

WHEREAS, the Village wishes to award the bid to A.C.T.S. Inc., at a cost of \$11.00 per square foot, as further described in the bid packet attached hereto as Exhibit A; and,

WHEREAS, the Board of Trustees of the Village believe it is in the best interest of the Village to accept the bid from A.C.T.S. Inc. as attached hereto.

NOW THEREFORE, BE IT ORDAINED by the President and Board of Trustees of the Village of Chatham, Sangamon County, Illinois, as follows:

Section 1. Recitals. The foregoing recitals shall be and are hereby incorporated into and made a part of this Resolution as if fully set forth in this Section 1.

Section 2. Acceptance of Bid. The Village hereby approves bid from A.C.T.S. Inc., at a cost of \$11.00 per square foot in a total amount not to exceed \$60,000.00 as further described in the bid packet attached hereto as **Exhibit A.** Any and all bids and parts thereof not explicitly approved by this Ordinance are hereby rejected. The Village authorizes the Village Manager and/or Village President, or designee of either, to execute any documents necessary to complete the purchases contemplated therein.

Section 3. Severability. In the event a court of competent jurisdiction finds this ordinance or any provision hereof to be invalid or unenforceable as applied, such finding shall not affect the validity of the remaining provisions of this ordinance and the application thereof to the greatest extent permitted by law.

Section 4. Repeal and Savings Clause. All ordinances or parts of ordinances in conflict herewith are hereby repealed; provided, however, that nothing herein contained shall affect any rights, actions, or causes of action which shall have accrued to the Village of Chatham prior to the effective date of this ordinance.

Section 5. Effective Date. This Ordinance shall be in full force and effect from and after its passage, approval and publication in pamphlet form as provided by law.

Route 4 Boring Project 2022

The Village of Chatham will be accepting sealed bids to bore underground primary along state right of way.

The Village of Chatham will be accepting sealed bids for boring underground utilities. Total length of the project 7000', boring in 3phase conductor, must be able to continuously bore for 2400' and handle all material.

Bid information will be available at the Village of Chatham Utility Office at 116 E Mulberry Chatham IL. 62629. Proposals must be submitted in a sealed envelope, via mail, hand-delivery or courier, and must be *received* by **1:00 PM, September 19, 2022** to be considered for selection.

The outside of the envelope should include the bidder's name and contact information and be clearly labeled to read:

All Contracts for the Construction of Public Works are subject to the Illinois Prevailing Wage Act (820 ILCS 130/1-12).

The Village reserves the right to accept or reject any and or all parts of the bid.

Bid requirement options:

Option 1:

All excavation performed by contractor. All Julie Laws must be followed.

Bores will consist of 3-350mcm CU 15kv conductors and 3-4/0 Cu conductors.

Bore depth will be no less than 48" or deeper than 60" at the existing grade.

Contractor must use approved equipment to pull conductor. This equipment must be approved before any wire can be pulled.

State ROW permit will be issued to the Village of Chatham. At no time will the contractor interfere with State Route traffic.

Contractor will provide reel trailers and all necessary equipment to handle the large 350 copper reels.

At no time will the unused reels be allowed to remain on the construction site overnight.

Option 2:

All excavation performed by contractor. All Julie Laws must be followed.

Bores will consist of 3-350mcm CU 15kv conductors and 3-4/0 Cu conductors.


Bore depth will be no less than 48" or deeper than 60" at the existing grade.
