ORDINANCE NO. 22- 47

**AN ORDINANCE APPROVING CONTRACT WITH
HALLELUJAH HOLIDAY LIGHTING**

WHEREAS, the Village of Chatham (“Village”) is an Illinois Municipal Corporation existing and operating under the Illinois Municipal Code and the laws of the State of Illinois; and

WHEREAS, the Village may enter into contracts with vendors for the purchase of goods and services; and

WHEREAS, Hallelujah Holiday Lighting is in the business of installing and deinstalling holiday lighting; and,

WHEREAS, the Village received a quote from Hallelujah Holiday Lighting to install holiday lights on the Chatham Square pavilion roofline, holiday wraps on 8 tree trunks on the pavilion, and holiday lights on 6 posts on the pavilion; and

WHEREAS, the Hallelujah Holiday Lighting quote includes deinstallation and storage of the holiday lights; and

WHEREAS, the Village has the option of accepting the quote for 2022 only at a cost of \$3,460.00, or the option of accepting the quote for 2022, 2023, and 2024 which includes a 30% discount off the cost for 2023 and 2024.

NOW THEREFORE, BE IT ORDAINED by the President and Board of Trustees of the Village of Chatham, Sangamon County, Illinois, as follows:

Section 1. Recitals. The foregoing recitals shall be and are hereby incorporated into and made a part of this Resolution as if fully set forth in this Section 1.

Section 2. Approval of Agreement. The Hallelujah Holiday Lighting quote for 2022 in the amount of \$3,460.00 is approved. The Hallelujah Holiday Lighting quote for 2023 and 2024 at a 30% discount is also approved.

Section 3. Execution of Agreement. The Village Manager, or his designees, is authorized to sign all related documentation to effectuate this transaction.

Section 4. Severability. In the event that any section, clause, provision, or part of this Ordinance shall be found and determined to be invalid by a court of competent jurisdiction, all valid parts that are severable from the invalid parts shall remain in full force and effect.

Section 5. Repeal and Savings Clause. All Ordinances or parts of Ordinances in conflict herewith are hereby repealed; provided, however, that nothing herein contained shall affect any rights, action, or causes of action which shall have accrued to the Village of Chatham prior to the effective date of this Ordinance.

Section 6. Effectiveness. This Ordinance shall be in full force and effect from and after its passage, approval, and publication in pamphlet form as provided by law.
