# ORDINANCE NO. 22-<u>4</u>9

## AN ORDINANCE SETTING VILLAGE BOARD MEETING DATES FOR CALENDAR YEAR 2023

WHEREAS, the Village of Chatham ("Village") is an Illinois Municipal Corporation existing and operating under the Illinois Municipal Code and the laws of the State of Illinois; and

WHEREAS, the Illinois Open Meetings Act, 5 ILCS 120/2.02, requires the Village to give public notice of the schedule of regular meetings at the beginning of each calendar or fiscal year and to state the regular dates, times, and places of such meetings; and

WHEREAS, the Village Board desires to adopt this Ordinance to set its schedule of the 2023 regular Village Board meetings and Committee of the Whole meetings; and

WHEREAS, the Village Board also desires to post and publish information on the other subsidiary bodies of the Village as set forth in this Ordinance.

**NOW THEREFORE, BE IT ORDAINED** by the President and Board of Trustees of the Village of Chatham, Sangamon County, Illinois, as follows:

- **Section 1.** Recitals. The foregoing recitals shall be and are hereby incorporated into and made a part of this Ordinance as if fully set forth in this Section 1.
- Section 2. Regular Village Board Meetings. For the year 2023, all Regular Village Board Meetings shall be held on the second and fourth Tuesday of each month, at 6 p.m., at Village Hall, 116 E. Mulberry Street in Chatham as set forth in Exhibit A.
- Section 3. Committee of the Whole Meetings. For the year 2023, all Committee of the Whole Meetings shall be held on the second Tuesday of each month, at 6:15 p.m., or as soon thereafter as the regular meeting is adjourned but no earlier than 6:15 p.m. at Village Hall, 116 E. Mulberry Street in Chatham as set forth in Exhibit A.

Section 4. Subsidiary Meetings. Other committees and commissions of the Village meet as needed and as set forth in Exhibit A.

**Section 5.** <u>Posting & Publication</u>. The Village Clerk is hereby directed to post the schedule of meetings, attached hereto as Exhibit A, and publish same with the Chatham Clarion.

**Section 6.** Severability. In the event that any section, clause, provision, or part of this Ordinance shall be found and determined to be invalid by a court of competent jurisdiction, all valid parts that are severable from the invalid parts shall remain in full force and effect.

**Section 7.** Repeal and Savings Clause. All Ordinances or parts of Ordinances in conflict herewith are hereby repealed; provided, however, that nothing herein contained shall affect any rights, action, or causes of action which shall have accrued to the Village of Chatham prior to the effective date of this Ordinance.

Section 8. <u>Effectiveness</u>. This Ordinance is effective upon its passage and publication.

## EXHIBIT A VILLAGE OF CHATHAM 2023 MEETING SCHEDULE

The Chatham Village Board shall hold regular meetings at 6:00 p.m. at 116 E. Mulberry Street in Chatham on the following dates in 2023:

January 10; January 24; February 14; February 28; March 14; March 28; April 11; April 25; May 9; May 23; June 13; June 27; July 11; July 25; August 8; August 22; September 12; September 26; October 10; October 24; November 14; November 28; December 12; and December 26.

The Chatham Village Board shall hold committee of the whole meetings at 6:15 p.m. (or as soon thereafter as the regular meeting of the Village Board adjourns but no sooner than 6:15 p.m.) at 116 E. Mulberry Street in Chatham on the following dates in 2022:

January 10; February 14; March 14; April 11; May 9; June 13; July 11; August 8; September 12; October 10; November 14; and December 12.

The Planning Commission Meetings shall be scheduled on the third Thursday of the month at 6:00 p.m. as needed.

The Zoning Board of Appeals Meetings shall be scheduled as needed with a minimum 15-day notice to the public at 6:00 p.m.

The Public Properties and Recreation Commission Meetings shall be held every other month on the second Monday of said month at 6:00 p.m. as posted.

The Police Pension Board Commission Meetings shall be held once a Quarter as posted.

The Police Commission Board Meetings shall be held once a Quarter as posted.

The Utility Oversight Committee Meetings shall be held every other month on the second Monday of the month at 6:00 p.m. as posted.

Special Meetings shall be called as needed by the Village Board with the required 48 hours' notice.
