ORDINANCE NO. 22 - <u>5</u>2

AN ORDINANCE AMENDING THE VILLAGE LIQUOR CODE PERTAINING TO THE NUMBER OF OUTSTANDING R-2G LIQUOR LICENSES

WHEREAS, the Village of Chatham (hereinafter "Village") is an Illinois Municipal Corporation existing and operating under the Illinois Municipal Code and the laws of the State of Illinois; and

WHEREAS, the Illinois Liquor Control Act of 1934, 235 ILCS 5/4-1, sets forth the rights of municipalities to govern and restrict the sale of alcoholic liquor within their communities; and

WHEREAS, Section 4-2 of the Act provides that the Village has the authority to determine the number, kind and classification of licenses for sale at retail of alcoholic liquor, not inconsistent with the Act, and the amount of local licensee fees to be paid for the various kinds of licenses to be issued; and

WHEREAS, Section 4-2 of the Act provides that the Village has the authority to establish such further regulations and restrictions upon the issuance of a local license not inconsistent with the law as the public good and convenience may require; and

WHEREAS, the Corporate Authorities of the Village believe it is in the best interest of the Village to amend the Village Liquor Code as set forth herein to decrease the number of outstanding Restaurant 2 Gaming liquor licenses by one (1).

NOW THEREFORE, BE IT ORDAINED by the President and Board of Trustees of the Village of Chatham, Sangamon County, Illinois, as follows:

Section 1. <u>Recitals</u>. The foregoing recitals shall be and are hereby incorporated into and made a part of this Ordinance as if fully set forth in this Section 1.

Section 2. <u>Amendment to Village Code</u>. Section 111.17 of the Village Code shall be amended as follows (added; deleted):

(C) The number of licenses issued by the village shall be as follows:

(17) There may be three two Class R-2G licenses;

Section 3. <u>Severability</u>. In the event that any section, clause, provision, or part of this Ordinance shall be found and determined to be invalid by a court of competent jurisdiction, all valid parts that are severable from the invalid parts shall remain in full force and effect.

Section 4. <u>Repeal and Savings Clause</u>. All Ordinances or parts of Ordinances in conflict herewith are hereby repealed; provided, however, that nothing herein contained shall affect any rights, action, or causes of action which shall have accrued to the Village of Chatham prior to the effective date of this Ordinance.

Section 5. <u>Effectiveness</u>. This Ordinance shall be in full force and effect from and after its passage, approval, and publication in pamphlet form as provided by law.
