ORDINANCE NO. 23-34
AN ORDINANCE ACCEPTING BID FOR
FENCE INSTALLATION

WHEREAS, the Village of Chatham (“Village”) is an Illinois Municipal Corporation existing and operating under the Illinois Municipal Code and the laws of the State of Illinois; and

WHEREAS, the Village requested bids for installation of fencing within the Village of Chatham; and

WHEREAS, the Village solicited bids in accordance with Illinois law for proposals from companies willing and able to provide the services requested, and the Village opened all bids on June 15, 2023; and,

WHEREAS, the bid documents made clear that the Village reserved the right to accept or reject any and/or all parts of the bid; and,

WHEREAS, the bid documents requested bids for installation of fencing; and,

WHEREAS, the Village received two bids from: (1) AMCO at a cost of \$36,660.00; and (2) Heneghan Construction Services, LLC at cost of \$64,673.00; and

WHEREAS, the Village wishes to award the bid to AMCO at a cost of \$36,660.00, as further described in the bid attached hereto as **Exhibit A**; and,

WHEREAS, the Board of Trustees of the Village believe it is in the best interest of the Village to accept the bid from AMCO as summarized.

NOW THEREFORE, BE IT ORDAINED by the President and Board of Trustees of the Village of Chatham, Sangamon County, Illinois, as follows:

Section 1. Recitals. The foregoing recitals shall be and are hereby incorporated into and made a part of this Resolution as if fully set forth in this Section 1.

Section 2. Acceptance of Bid. The Village hereby approves the bid from AMCO at a cost of \$36,660.00 as further described in the bid attached hereto as **Exhibit A**. Any and all bids

and parts thereof not explicitly approved by this Ordinance are hereby rejected. The Village authorizes the Village Manager and/or Village President, or designee of either, to execute any documents necessary to complete the purchases contemplated therein.


Section 3. Severability. In the event a court of competent jurisdiction finds this ordinance or any provision hereof to be invalid or unenforceable as applied, such finding shall not affect the validity of the remaining provisions of this ordinance and the application thereof to the greatest extent permitted by law.

Section 4. Repeal and Savings Clause. All ordinances or parts of ordinances in conflict herewith are hereby repealed; provided, however, that nothing herein contained shall affect any rights, actions, or causes of action which shall have accrued to the Village of Chatham prior to the effective date of this ordinance.

Section 5. Effective Date. This Ordinance shall be in full force and effect from and after its passage, approval and publication in pamphlet form as provided by law.

Fence Requirements

800 feet of 6 ft. tall solid style wood fence. 2.5 inch round galvanized steel posts. All posts to be set in concrete.

2x4 runners to posts with wood adapter clamps

Boards: 1 inch x 6 inch x 6 ft. Western Red Cedar

Runners: 2x4 inch treated pine.

Removal of existing fence will be done by Village of Chatham crews.


Notes/Conditions reflective of our understanding of the project and included in this proposal:

- 1) We are proposing 3 runners – top, middle, and bottom.
- 2) The new fence proposed is “dog eared” Western Red Cedar.
