That part of the North Half of the Southwest Quarter of Section 6, Township 14 North, Range 5 West of the Third Principal Meridian, described as follows: Beginning at the Southwest corner of said Half Quarter Section and running thence North 4.37½ chains; thence East parallel with the South line of said Half Quarter Section to the West line of the Right of Way of the Illinois Traction Company; thence in a Southwesterly direction along said Right of Way line 4.67½ chains to the South line of said Half Quarter Section; thence West along the South line of said Half Quarter Section, 32.15½ chains to the place of beginning, containing 14.44 acres, Except all Highways and Dedications of record,

AND

That part of the North Half of the Southwest Quarter of Section 6, Township 14 North, Range 5 West of the Third Principal Meridian, described as follows: Beginning at a point 4.37½ chains North of the Southwest corner of said Half Quarter Section, and running thence North 4.32½ chains; thence East 35.52 3/4 chains to the West line of strip of land conveyed to the Decatur, Springfield, and St. Louis Railroad Company by quit claim deed filed in the Recorder's Office of Sangamon County, Illinois, on May 28, 1903, and recorded in Book 106 of Deeds, page 631; thence in a Southwesterly direction along the West line of said strip of land, 4.62½ chains and thence West 33.85 chains to the place of beginning excepting therefrom the following described real estate: A plot of ground beginning on the East right of way line of State Route 4 as it existed on February 11, 1976, (or 31 feet East of the West line of said Section 6) thence running East along the North line of the above described tract 170 feet to a point, thence running South 160 feet along a line parallel to the said West line of Section 6, to a point, thence running West 170 feet parallel to the North line above described, thence running North 160 feet along the East right of way line of said State Route 4 to the point of beginning of this plot.
