



AN AGREEMENT

BETWEEN

SPRINGFIELD AND SANGAMON COUNTY

COMMUNITY ACTION

AND

THE VILLAGE OF CHATHAM, IL.

In order to allow the customers of Sangamon County to receive financial aid from the Community Services Administration's Special Crisis Intervention program, the Village of Chatham Electric Utility agrees to the following conditions:

1. that the outstanding bill of the fuel customer is reduced by the full amount of the Special Crisis Intervention program payment;
2. that for any remaining balance, the customer is offered a deferred payment arrangement. The maximum amount allowable under the deferred payment for Emergency Assistance participants will be \$25.00 per month plus the amount of the current utility bill. The deferred payment is to be made on the customer's regular due date;
3. that a reconnection charge, to be paid by the customer, is included in the deferred amount and not charged against the grant;
4. that no security deposit is required to be paid except where such a deposit was required by State Law or explicit State Regulations prior to May 5, 1977, and where required by State Law, or explicit State Regulations, the deposit to be included in a deferred payment arrangement;
5. that reconnection of service is made upon certification for payment and satisfaction of the above requirements.
