

Dear Mayor Mowery:

Enclosed is a resolution passed by the Village of Chatham on June 9, 1992, which commits the Village of Chatham to supplying the Village of Loami with water should the Village of Loami fund and construct a water main from the Village of Loami to the Village of Chatham. The commitment is good for four years from the date of the resolution; upon completion of the water main, the Village of Chatham will commit to supplying your requirement for 25 year

As you may be aware, the Village of Chatham obtains its water from the City of Springfield under a long term supply agreement which expires in the year 2010; the agreement can be terminated by either party prior to that time under certain conditions and provides that Chatham must secure Springfield's written permission to serve customers outside of Chatham. While the Village of Chatham will use best efforts to provide the Village of Loami's requirements, there is no guarantee that this supply arrangement with the City of Springfield will last indefinitely or even until 2010. Hence, the enclosed resolution is tendered to you with the understand that chatham is committed only to using best efforts to obtaining an adequate supply of water for Loami, up to 100,000 gallons per day, and that if the Springfield water supply should become unavailable or should Springfield refuse to give the necessary permission, Loami may have to look to other sources of supply.

The agreement will provide that Chatham will supply water at its cost.

We would appreciate it if you would approve the understanding expressed in this letter by Board action and sign and return a copy of this letter for our files.

We are most delighted to have this opportunity to work with a sister unit of government in solving a pressing problem. We look forward to a long and happy relationship with the Village of Loami.
