Resolution No. 13 -92

A RESOLUTION AUTHORIZING LETTER OF CREDIT REDUCTIONS PERTAINING TO SOUTHWINDS SUBDIVISION, PLATS I, II, III AND IV

WHEREAS, on September 4, 1991, Magna Bank of Central Illinois, provided the Village of Chatham with a letter of credit in the amount of \$100,000 to secure the construction of public improvements in all final plats of Southwinds Subdivision;

WHEREAS, the developer of Southwinds Subdivision Plats I, II, III and IV has requested a full release of the letter of credit with respect to Southwinds Subdivision Plats I, II, and III, and a reduction in the amount of the letter of credit securing performance with respect to Southwinds Subdivision Plat IV to the amount of \$8,750;

WHEREAS, the public improvements for Plats I, II and III are substantially complete with only a few remaining items, and there remain approximately \$7,000 worth of public improvements to be completed with respect to Plat IV;

WHEREAS, the subdivider has requested that the letter of credit be released in its entirety as to Plats I, II and III and increased to \$10,000 for Plat IV, with the understanding that the letter of credit will cover the few remaining items in Plats I, II and III;

WHEREAS, the remaining public improvements for Plats I, II III and IV are reflected in correspondence between the Village engineer and the Village Manager attached to this resolution as Exhibit A. NOW, THEREFORE, BE IT RESOLVED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF CHATHAM, SANGAMON COUNTY, ILLINOIS, AS FOLLOWS:

SECTION 1: The letter of credit with respect to Plats I, II and III of Southwinds Subdivision is hereby released.

SECTION 2: The letter of credit with respect to Plat IV is released except for \$10,000, with the understanding that the \$10,000 with respect to Plat IV will also serve as surety for performance of the items with respect to Plats I, II and III reflected in a letter from Greene and Bradford, Inc. to Del McCord, attached hereto as Exhibit A.

SECTION 3: This Resolution is effective immediately. PASSED this 11th day of August, 1992.
