

Resolution No. 25-93

**A RESOLUTION AUTHORIZING THE INSTALLATION
OF CERTAIN PLAYGROUND EQUIPMENT AND
PARTICIPATION IN THE COST THEREOF**

WHEREAS, Mr. Aaron Gallagher, as part of an Eagle Scout project, has offered to install certain playground equipment in the Village Park;

WHEREAS, the Kiwanis Club has offered to donate \$1,000 toward the cost of the equipment, which has an estimated cost of \$2,000;

WHEREAS, Mr. Gallagher has sought the participation of the Village in the cost of installing the equipment.

NOW, THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF CHATHAM, SANGAMON COUNTY, ILLINOIS, AS FOLLOWS:

SECTION 1: The Village hereby commits to participate with Mr. Gallagher in the installation of playground equipment identified by Mr. Gallagher in the Village Park, as set forth herein.

SECTION 2: The Village will participate in the cost of installation of the playground equipment in the amount of \$1,000, plus paying for miscellaneous concrete work as approved by the Village Administrator.

SECTION 3: The Village Administrator is authorized and directed to carry out this Resolution, and to aid Mr. Gallagher as set forth herein and in any other way in which Mr. Gallagher may reasonably request.

SECTION 4: This Resolution is effective immediately.
