A RESOLUTION AUTHORIZING LETTER OF CREDIT REDUCTIONS PERTAINING TO BRECKENRIDGE SUBDIVISION, PLATS II AND III

WHEREAS, on July 15, 1993, First of America Bank provided the Village of Chatham with letters of credit in the amount of \$495,000 and \$650,000 to secure the construction of public improvements in Plats II and III of Breckenridge Subdivision;

WHEREAS, the developer of Breckenridge Subdivision Plats II and III has requested a reduction in the amount of the letter of credit securing performance with respect to Breckenridge Subdivision Plats II and III;

WHEREAS, many public improvements are complete, but the remaining public improvements for Plats II and III are reflected in correspondence between the Village Engineer and the Village Attorney attached to this resolution as Exhibit A;

NOW, THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF CHATHAM, SANGAMON COUNTY, ILLINOIS, AS FOLLOWS:

SECTION 1: The letter of credit with respect to Plat II of Breckenridge Subdivision is hereby released except for \$71,500, and the letter of credit with respect to Plat III is hereby released except for \$153,500.
