A RESOLUTION AUTHORIZING SECURITY REDUCTION FOR HURSTBOURNE SUBDIVISION, PLATS I THROUGH IV

WHEREAS, on December 6, 1994 Magana Bank provided a letter of credit Number 9176 in the amount of \$160,000 to secure the construction of public improvements in Plats I through III and all subsequent plats of Hurstbourne Subdivision;

WHEREAS, the developer of Hurstbourne Subdivision has requested a reduction in the amount of the letter of credit securing performance with respect to Plat IV;

WHEREAS, the public improvements for Plat IV are partially complete and there remain approximately \$33,000 worth of public improvements to be completed with respect to Plat IV;

WHEREAS, the remaining public improvements for said plat are reflected in correspondence from the Village's Consulting Engineer, attached to this resolution as Exhibit A, and the Village Consulting Engineer has recommended reduction of the letter of credit to \$33,000, which, together with security for Plats I, II and III previously approved in the amount of \$32,350, would permit reduction of the security for all Plats in Hurstbourne subdivision to the sum of of \$65,350.

NOW, THEREFORE, BE IT RESOLVED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF CHATHAM, SANGAMON COUNTY, ILLINOIS, AS FOLLOWS:

SECTION 1: The security with respect to Plats I through IV of Hurstbourne Subdivision Plat IV, Magana Bank Letter of Credit No. 9176, is hereby released except to the extent of \$65,350.

SECTION 2: This Resolution is effective immediately.
