A RESOLUTION AUTHORIZING LETTER OF CREDIT REDUCTIONS PERTAINING TO OAKBROOK ESTATES SUBDIVISION, PLATS 1, 2 AND 3

WHEREAS, on April 25, 1995 the First National Bank provided the Village of Chatham with a letter of credit Number 1713 in the amount of \$540,000, to secure the construction of public improvements in Plat 1 of Oakbrook Estates Subdivision;

WHEREAS, pursuant to Ordinance 96-05, letter of credit No. 1713 was approved as security for public improvements in Plat 3 of Oakbrook Estates Subdivision;

WHEREAS, pursuant subsequent resolutions, the Village partially released the security for Plats 1 and 3 to the sum of \$75,000;

WHEREAS, on April 9, 1996, the First National Bank issued its letter of credit No. 1724 in the amount of \$255,000 to secure the construction of public improvements in Plat 2 of Oakbrook subdivision;

WHEREAS, pursuant to Ordinance No. 96-__, letter of credit No. 1724 was approved as sucurtity for Plat 2, and pursuant to subsequent resolutions, the Village partially released the security for Plat 2 to the sum of \$132,000;

WHEREAS, public improvements in Plats 1, 2 and 3 have been further constructed, and the developer of Oakbrook Estates Subdivision has requested a further partial release of the letters of credit;

WHEREAS, security in the amount of \$37,000 is sufficient to secure construction of the remaining public improvements for Plats 1 and 3, and security in the amount of \$24,000

is sufficient to secure construction of the remaining public improvements for Plat 2; and as reflected in correspondence from the Consulting Engineer for the Village dated May 19, 1997 attached hereto as Exhibit A, the Consulting Engineer for the Village has recommended reduction of the letters of credit to such amounts.

NOW, THEREFORE, BE IT RESOLVED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF CHATHAM, SANGAMON COUNTY, ILLINOIS, AS FOLLOWS:

SECTION 1: Letter of credit Number 1713, dated April 25, 1995, with respect to Plats 1 and 3 of Oakbrook Estates Subdivision, is hereby partially released, to the amount of \$37,000.

SECTION 2: Letter of credit Number 1724, dated April 6, 1996, with respect to Plat 2 of Oakbrook Estates Subdivision, is hereby partially released, to the amount of \$24,000.

SECTION 3: This Resolution is effective immediately.

The attached letters from Mr. Jay Jessen, April 30, 1997 has requested that the Letter of Credit for Oakbrook Estates be reduced to the following;

Plat 1, \$9,000 Plat 2, \$17,000 Plat 3, \$23,000

Total of all three Letters of Credit = \$49,000

All of these plats have had final inspections regarding the streets, water, drainage, and sewers, the only item that remains is the sidewalk that is being installed by each property owner as they build. We inspected these plats again today and found the following sidewalks needing to be completed:

Plat 1, 4,672 square feet @ $2.25/s.f. = 10,512 \times 1.25 = 13,140 \text{ say } \$13,000$

Plat 2, 6069 square feet, use Jay's amount of \$17,000

Plat 3, 8518 square feet @ $2.25/s.f. = 19,166 \ge 1.25 = 23,957$ say \$24,000

Total of all three Letters of Credit = \$54,000
