

**A RESOLUTION FOR IMPROVEMENT BY  
MUNICIPALITY UNDER THE ILLINOIS HIGHWAY CODE**

**BE IT RESOLVED BY THE PRESIDENT AND BOARD OF TRUSTEES OF  
THE VILLAGE OF CHATHAM, SANGAMON COUNTY, ILLINOIS, AS FOLLOWS:**

**SECTION 1:** That the following described streets be improved under the Illinois Highway Code:

- Spruce from State to easterly 500 feet
- Hazel, Maple, & Poplar from Spruce to Chestnut
- South Main from bridge 1050 feet North TR 115 to Northerly 4000 feet
- Crestview from Cottonwood to end
- Parkview from Cottonwood to end
- Highland from Cottonwood to end


**SECTION 2:** That the porposed improvement shall consist of Butt Joints, Bituminous and Aggregate Prime Coats, Leveling Binder, Bituminous Concrete Surface Course and Adjustment of Manholes, and shall be constructed variable in width and be designated as Section 98-00020-00-RS.

**SECTION 3:** That there is hereby appropriated the sum of \$95,000 for the improvement of said section form the municipalitys allotment of Motor Fuel Tax funds. The work shall be done by contract


**SECTION 4:** The Village Clerk is hereby directed to attest and transmit two certified copies of the attached resolution to the district office of the Department of Transportation..

2. That there is hereby appropriated the (additional) sum of Ninety five thousand Dollars ( \$95,000.00 ) for the improvement of said section from the municipality's allotment of Motor Fuel Tax funds.

3. That work shall be done by Contract; and, Specify Contract or Day Labor
