A RESOLUTION ABATING THE DIRECT ANNUAL REAL ESTATE TAX IN THE AMOUNT OF \$137,540.00 FOR THE YEAR 2000 LEVIED PURSUANT TO ORDINANCE NO. 92-31

WHEREAS, pursuant to Ordinance No. 92-31, the corporate authorities of the Village of Chatham levied a tax for the levy year 2000 in the amount of \$137,540.00 to cover principal and interest charges for the year 2000 for those certain bonds designated as "Village of Chatham General Obligation Refunding Bonds (Alternate Revenue Source), Series 1002";

WHEREAS, Section 10 of that Ordinance provides that in the event there are monies irrevocably on deposit in the Debt Service Account of 1002 sufficient to pay and discharge the principal and interest on said bonds for the period for which said taxes were levied, the Village Board shall duly direct the abatement of such taxes and timely file the same with the County Clerk;

WHEREAS, the Treasurer of the Village of Chatham has reported, and the corporate authorities find, that there are and irrevocably shall remain in the Debt Service Account of 1002 of the Village of Chatham sufficient funds to pay principal and interest on said bonds for 2000;

WHEREAS, the direct annual real estate tax levied pursuant to Ordinance No. 92-31 for 2000 must therefore be abated.

NOW, THEREFORE, BE IT RESOLVED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF CHATHAM, SANGAMON COUNTY, ILLINOIS, AS FOLLOWS:

SECTION 1: That certain tax levied for the year 2000 in the amount of \$137,540.00 to cover principal and interest charges for 2000, which tax was levied pursuant to Section 10 of "An Ordinance Authorizing the Issuance of \$1,985,000 General Obligation Refunding Bonds (Alternate Revenue Source), Series 1002, of the Village of Chatham, Sangamon County, Illinois, Providing the Details of Such Bonds and for an Alternate Revenue Source and the Levy of Direct Annual Taxes Sufficient to Pay the Principal of and Interest on Such Bonds, and Related Matters", Ordinance No. 92-31, is hereby abated.

SECTION 2: The Clerk of the Village of Chatham is hereby directed to file forthwith a certified copy of this resolution with the County Clerk of Sangamon County, Illinois.
