Dear Steve:

I am in receipt of the above plan and offer the following comments:

- 1. The acreage is already annexed and zoned; circa 1999.
- 2. Sewer is available as we required a 10" main be extended along Gordon Drive.
- 3. Water and electric are immediately available on the north and south of the area.
- 4. All entrance permits will be through the Village as the County jurisdiction / maintenance begins near the Pleasant Park Daycare (according to 1991 agreement).
- 5. Due to existing drainage patterns, I suggest you reserve the rear of lots 35/36 (behind daycare) for open space and detention. There is a 18" or 21" storm sewer stubbed to the area.
- 6. It appears that the center east-west through street will directly line up with Magnolia Drive to the west. This street name should be noted on the Preliminary Plan.
