Walnut Street/Chatham Road (FAU 8146) from the 506 feet east of the intersection of Gordon Drive (FAS 638) east to the intersection of Sanctuary Park Road, a distance of 0.61 miles, in its entirety; and,

WHEREAS, the Village agrees to accept jurisdiction and maintenance of a portion of County Highway 40 (CH 40) known as W. Walnut Street/E. Loami Road (FAU 8146) from the intersection of Illinois Route 4 (FAP 662) west to 665 feet west of the intersection of Savannah Road (FAU 8154), a distance of 0.94 miles, in its entirety and including Structure Number 084-3412, in its present condition; and,

WHEREAS, the County will continue to maintain the above portions of E. Walnut Street/Chatham Road and W, Walnut Street/E, Loami Road until the Illinois Department of Transportation approves the Local Agency Agreement for Jurisdictional Transfer; and,

WHEREAS, the County recognizes that the terms of the agreement entered into by the County and Village on February 3, 2000 which outlined cost sharing for the improvement to the Gordon Drive and Walnut Street intersection are completed as the funding set aside by the Village will now be used towards a Village street instead of a County highway as compensation for these jurisdictional transfers.

NOW THEREFORE BE IT RESOLVED, by the President and Board of Trustees of the Village of Chatham as follows:

SECTION 1: That the "Local Agency Agreements for Jurisdictional Transfer" between Sangamon County and the Village of Chatham, be approved; and,

SECTION 2: That the President of the Village of Chatham is hereby authorized and directed to sign said Agreements for Jurisdictional Transfer on behalf of the Village.
