A RESOLUTION ABATING THE DIRECT ANNUAL REAL ESTATE TAX IN THE AMOUNT OF \$123,459.00 FOR THE YEAR 2012 LEVIED PURSUANT TO ORDINANCE NO. 09-62

WHEREAS, pursuant to "An Ordinance Of The Village Of Chatham, Sangamon County, Illinois, Authorizing The Issuance Of General Obligation Bonds (Alternate Revenue Source), Series 2009, Of The Village In The Aggregate Principal Amount Of \$690,000 For The Purpose Of Defraying The Cost Of Certain Street, Sidewalk, Drainage and Utility Improvements of the Village and Refunding Certain Prior Outstanding Bonds of the Village," Ordinance No. 09-62, the corporate authorities of the Village of Chatham levied a tax for the levy year 2012 in the amount of \$123,459.00 to cover principal and interest charges for the year 2013 for those certain bonds designated as "General Obligation Bond (Alternate Revenue Source) Series 2009";

WHEREAS, Section 15 of that Ordinance provides that in the event there are sufficient Pledged Revenues (as defined in that Ordinance) on hand in an amount not less than the debt service on the outstanding bonds for the period for which the taxes were levied, the Village Board shall duly direct the abatement of such taxes and timely file the same with the County Clerk;

WHEREAS, the Treasurer of the Village of Chatham has reported, and the corporate authorities find, that there are sufficient Pledged Revenues (as defined in that Ordinance) on hand in an amount not less than the debt service on the outstanding bonds for the period for which the taxes were levied;

WHEREAS, the direct annual real estate tax levied pursuant to Ordinance No. 09-62 for 2012 must therefore be abated.

NOW, THEREFORE, BE IT RESOLVED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF CHATHAM, SANGAMON COUNTY, ILLINOIS, AS FOLLOWS:

\$123,459.00 to cover principal and interest charges for 2013, which tax was levied pursuant to Section 15 of "An Ordinance Of The Village Of Chatham, Sangamon County, Illinois, Authorizing The Issuance Of General Obligation Bonds (Alternate Revenue Source), Series 2009, Of The Village In The Aggregate Principal Amount Of \$690,000 For The Purpose Of Defraying The Costs of Certain Street, Sidewalk, Drainage, and Utility Improvements of the Village," Ordinance No. 09-44, is hereby abated.

SECTION 2: The Clerk of the Village of Chatham is hereby directed to file forthwith a certified copy of this resolution with the County Clerk of Sangamon County, Illinois.
