

RESOLUTION NO. 55 - 15

A RESOLUTION APPROVING THE LEASE AND PURCHASE OF TWO BACKHOE SNOW PUSHERS FROM MARTIN EQUIPMENT BY THE VILLAGE OF CHATHAM

WHEREAS, the Village of Chatham ("Village") is an Illinois Municipal Corporation existing and operating under the Illinois Municipal Code and the laws of the State of Illinois; and

WHEREAS, the Village is in need of backhoe snow pushers for the care and maintenance of its roads during the winter; and

WHEREAS, the Village solicited quotations for such backhoe snow pushers; and,

WHEREAS, Martin Equipment submitted the lowest quotation for lease of such items with the option to purchase.

NOW THEREFORE, BE IT RESOLVED by the President and Board of Trustees of the Village of Chatham, Sangamon County, Illinois, as follows:

Section 1. Recitals. The foregoing recitals shall be and are hereby incorporated into and made a part of this Resolution as if fully set forth in this Section 1.


Section 2. Approval of Purchase. The Village Board of Trustees hereby approves the rent/purchase agreement submitted by Martin Equipment for two 10-foot backhoe snow pushers in the amount of \$750 per 10-foot backhoe snow pusher for rent in November 2015, December 2015, January 2016, and February 2016 with the option to purchase in March 2016 for \$350.00 each. The total amount approved by the Village Board of Trustees to be spent is \$6,700 on the two 10-foot backhoe snow pushers.

Section 3. Effective Date. This Resolution shall be in full force and effect from and after its passage and approval.
