## RESOLUTION NO. 23-16

## A RESOLUTION ESTABLISHING A TEMPORARY SUPPLEMENTAL FLUSHING FEE ON VILLAGE CUSTOMER WATER BILLS FOR THE VILLAGE'S FLUSHING PROGRAM

WHEREAS, the Village of Chatham ("Village") is an Illinois Municipal Corporation existing and operating under the Illinois Municipal Code and the laws of the State of Illinois; and

WHEREAS, for water service, the Village has adopted a minimum rate, basic usage rate per 1,000 gallons used, a facility charge, and a bulk water charge; and

WHEREAS, the Village has passed Ordinance 15-28, allowing the Village to set the Water Rate by Resolution; and,

WHEREAS, the Village previously approved water rates for the Village and desires those rates to continue into effect; and

WHEREAS, the Village is planning to embark on a flushing program within the Village in 2016, which will be a significant cost to the Village; and

**WHEREAS**, to fund the flushing program, the Village Board desires to add an additional temporary \$2.50 fee per month to each water customer; and

WHEREAS, the President and Board of Trustees of the Village believe it is in the best interests of the Village to adopt this Resolution setting forth the temporary fee for the flushing program and to provide prior notice of the temporary fee.

**NOW THEREFORE, BE IT RESOLVED** by the President and Board of Trustees of the Village of Chatham, Sangamon County, Illinois, as follows:

**Section 1.** Recitals. The foregoing recitals shall be and are hereby incorporated into and made a part of this Resolution as if fully set forth in this Section 1.

**Section 2.** <u>Temporary Supplemental Flushing Fee.</u> The Village Board hereby authorizes the issuance of a 12-month additional \$2.50 monthly flushing fee for all water customers, effective August 1, 2016, to expire on July 31, 2017.

Section 3. Notice. The Village shall provide notice of the Temporary Supplemental Flushing Fee on its utility bills

**Section 4.** Effective Date. This Resolution shall be in full force and effect from and after its passage, approval and publication in pamphlet form as provided by law.
