A RESOLUTION ABATING THE DIRECT ANNUAL REAL ESTATE TAX IN THE AMOUNT OF \$348,421.00 FOR THE YEAR 2016 LEVIED PURSUANT TO ORDINANCE NO. 14-04

WHEREAS, pursuant to "An Ordinance Of The Village Of Chatham, Sangamon County, Illinois, Authorizing The Issuance Of General Obligation Refunding Bonds(Alternate Revenue Source), Series 2014, Of The Village In The Aggregate Principal Amount Of \$3,805,000 For The Purpose Of Refunding Certain Outstanding Prior Bonds of The Village," Ordinance No. 14-04, the corporate authorities of the Village of Chatham levied a tax for the levy year 2016 in the amount of \$348,421.00 to cover principal and interest charges for the year 2017 for those certain bonds designated as "General Obligation Refunding Bonds (Alternate Revenue Source) Series 2014";

WHEREAS, Section 15 of that Ordinance provides that in the event there are sufficient Pledged Revenues (as defined in that Ordinance) on hand in an amount not less than the debt service on the outstanding bonds for the period for which the taxes were levied, the Village Board shall duly direct the abatement of such taxes and timely file the same with the County Clerk;

WHEREAS, the Treasurer of the Village of Chatham has reported, and the corporate authorities find, that there are sufficient Pledged Revenues (as defined in that Ordinance) on hand in an amount not less than the debt service on the outstanding bonds for the period for which the taxes were levied;

WHEREAS, the direct annual real estate tax levied pursuant to Ordinance No. 14-04 for 2016 must therefore be abated.
