## A RESOLUTION ACCEPTING THE LOWEST RESPONSIBLE BIDS FOR THE VILLAGE OF CHATHAM WATER DISTRIBUTION MATERIAL

WHEREAS, the Village of Chatham ("Village") is an Illinois Municipal Corporation existing and operating under the Illinois Municipal Code and the laws of the State of Illinois; and

WHEREAS, the Village has established its combined waterworks system for the use and benefit of its citizens; and

WHEREAS, the Village solicited bids for several different water distribution materials, said bids needing to be submitted on or before  $\underline{10}$  p.m. on  $\underline{10}$ , 2017; and

WHEREAS, the Village opened such bids at in accordance with Illinois law at 1.00 on 2017, with several different companies being award the low bid depending on part being bid; and,

WHEREAS, the Village Board believes it to be in the best interest of the Village to purchase each part or set of parts from the lowest responsible bidder; and,

WHEREAS, the lowest bid for the Dual Meter Setter Pit was submitted by Schulte; however, said Dual Meter Setter Pit did not meet the specifications of the bid so the part will be purchased from Midwest Meter.

**NOW THEREFORE, BE IT RESOLVED** by the President and Board of Trustees of the Village of Chatham, Sangamon County, Illinois, as follows:
