

RESOLUTION NO. 10-35-18

**AN RESOLUTION ESTABLISHING ELECTRIC RATE FOR THE
VILLAGE OF CHATHAM AS OF SEPTEMBER 1, 2018**

WHEREAS, the Village of Chatham ("Village") is an Illinois Municipal Corporation existing and operating under the Illinois Municipal Code and the laws of the State of Illinois; and

WHEREAS, for electric service, the Village has adopted a basic user rate per kilowatt-hour (kWh) and a monthly facility charge unrelated to usage; and

WHEREAS, the Village has passed Ordinance 15-26, allowing the Village to set the Electric Rate by Resolution; and

WHEREAS, the President and Board of Trustees of the Village believe it is just and proper to provide prior notice to the public of all rate changes.

NOW THEREFORE, BE IT RESOLVED by the President and Board of Trustees of the Village of Chatham, Sangamon County, Illinois, as follows:

Section 1. Recitals. The foregoing recitals shall be and are hereby incorporated into and made a part of this Resolution as if fully set forth in this Section 1.

Section 2. Rates. The Rates as of September 1, 2018 shall be as follows:

(A) Standard residential service (ER01 & ER02).

(1) Rate: \$0.1135/kwh;

(2) Facility Charge: \$11.57 per month;

(3) Fuel Adjustment: As per § 52.013 of this Code of Ordinances;

(4) Application: All residential customers for single-phase service through a single meter for domestic use;

(5) Nature of Service: Alternating current, 60 cycle, single phase, 120/240 nominal volts.

(B) Senior citizen residential service (SR01 & SR02).

(1) Rate: \$0.1022/kwh;
(2) Facility Charge: \$11.57 per month;
(3) Fuel Adjustment: As per § 52.013 of this Code of Ordinances;
(4) Application: Retired persons having attained the age of 62 years where there is no one residing in the residence for which electric service is provided who is employed. Written application for this favorable rate must be made and the Director of Utilities may from time to time require re-application;

(5) Nature of Service: Alternating current, 60 cycle, single phase, 120/240 nominal volts.

(C) Parks service.

(1) Rate: \$0.1022/kwh;
(2) Facility Charge: \$11.57 per month;
(3) Fuel Adjustment: N/A;
(4) Application: Written application designating responsible person and contact number;
(5) Nature of Service: Alternating current, 60 cycle, single phase, 120/240 nominal volts.

(D) Governmental (GV01 & DM01).

(1) Rate:
(a) \$0.1022/kwh;
(b) \$6.2738/per multiplier/per demand unit (demand will be the highest average kilowatt demand measured in any 15-minute period during the month);
(2) Facility Charge: \$24.87 per month;
(3) Fuel Adjustment: As per § 52.013 of this Code of Ordinances;
(4) Application: Governmental bodies duly established under the laws of the State of Illinois or the United States of America;

(5) Nature of Service: Service will be delivered at one utilization voltage point and meter. Any exception to the foregoing will be treated as supplemental facilities. Alternating current will be supplied at 60 cycle, 120/240 nominal volts, single or three phase. When requested by the customer, the utility will supply alternating current, 60 cycle, 120/208 nominal volts, if available.

(E) Commercial service without demand (ER01 & ER04).

(1) Rate: \$0.1339/kwh;

(2) Facility Charge:

(a) \$11.57 per month single phase;

(b) \$25.87 per month three phase.

(3) Fuel Adjustment: As per § 52.013 of this Code of Ordinances;

(4) Application: Commercial, institutional, and non-residential or for three phase, residential, non-residential, institutional, and commercial use taken through a single meter at the utility standard secondary voltage without demand metering;

(5) Nature of Service: Service will be delivered at one utilization voltage point and meter. Any exception to the foregoing will be treated as supplemental facilities. Alternating current will be supplied at 60 cycle, 120/240 nominal volts, single or three phase. When requested by the customer, the utility will supply alternating current 60 cycle, 120/208 nominal volts, if available.

(F) Commercial service with demand (EN01 EN03 & DM01 DM03).

(1) Rate:

(a) \$0.1061/kwh;

(b) \$6.2738/per multiplier/per demand unit (demand will be the highest average kilowatt demand measured in any 15-minute period during the month).

(2) Facility Charge:

(a) \$11.57 per month single phase;

(b) \$24.87 per month three phase.

(3) Fuel Adjustment: As per § 52.013 of this Code of Ordinances;

(4) Application: Commercial, institutional, and non-residential or for three phase, residential, non-residential, institutional, and commercial use taken through a single meter at the utility standard secondary voltage without demand metering;

(5) Nature of Service: Service will be delivered at one utilization voltage point and meter. Any exception to the foregoing will be treated as supplemental facilities. Alternating current will be supplied at 60 cycle, 120/240 nominal volts, single or three phase. When requested by the customer, the utility will supply alternating current 60 cycle, 120/208 nominal volts, if available.

(G) Industrial service (EN02 & DM02).

(1) Rate:

(a) \$0.0928/kwh;

(b) \$8.3543/per multiplier/per demand unit (demand will be the highest average kilowatt demand measured in any 15-minute period during the month, minimum of 70kw. The village may determine the actual demand either by permanently installed instruments or by tests.)

(2) Facility Charge:

(a) \$19.90 per month single phase;

(b) \$49.75 per month three phase.

(3) Fuel Adjustment: As per § 52.013 of this Code of Ordinances;

(4) Application: Commercial, industrial or manufacturing facilities.

(5) Nature of Service: Service will be delivered at one utilization voltage point and meter. Any exception to the foregoing will be treated as supplemental facilities. Alternating current will be supplied at 60 cycles, 120/240 nominal volts, single or three phase. When requested by the

customer, the utility will supply alternating current 60 cycles, 120/208 nominal volts, if available.

(H) Security lighting (SL01). Rate: \$8.45/kwh.

Section 3. Date Rate Change Goes into Effect. The new rates shall be posted on consumers' bills for the next billing cycle, and rates shall be posted in Village Hall and on the Village website as soon as practicable. The new rates shall go into effect on September 1, 2018.

Section 4. Effective Date. This Resolution shall be in full force and effect from and after its passage and approval.
