RESOLUTION NO. 22 -19

A RESOLUTION ESTABLISHING THE WATER RATES FOR THE VILLAGE OF CHATHAM

WHEREAS, the Village of Chatham ("Village") is an Illinois Municipal Corporation existing and operating under the Illinois Municipal Code and the laws of the State of Illinois; and

WHEREAS, for water service, the Village has adopted a minimum rate, basic usage rate per 1,000 gallons used, a facility charge, and a bulk water charge; and

WHEREAS, the Village has passed Ordinance 15-28, allowing the Village to set the Water Rate by Resolution; and,

WHEREAS, the President and Board of Trustees of the Village believe it is just and proper to provide prior notice to the public of all rate changes.

NOW THEREFORE, BE IT RESOLVED by the President and Board of Trustees of the Village of Chatham, Sangamon County, Illinois, as follows:

Section 1. <u>Recitals</u>. The foregoing recitals shall be and are hereby incorporated into and made a part of this Resolution as if fully set forth in this Section 1.

Section 2. <u>Rates for Inside Village Limits Consumption</u>. The rates for consumption inside of the Village limits as of July 1, 2019, shall be as follows: (i) Facility Charge of \$25.99 per month; (ii) Consumption Charge of \$9.72 per 1,000 gallons consumed; and (iii) Water Tank Maintenance Fee of \$2.50 per month which said fee shall automatically expire on August 31, 2027.

Section 3. <u>Rates for Outside Village Limits Consumption</u>. The rates for consumption outside the Village limits as of July 1, 2019, shall be as follows: (i) Facility Charge of \$32.49 per month; (ii) Consumption Charge of \$13.34 per 1,000 gallons consumed; and (iii) Water Tank Maintenance Fee of \$2.50 per month for a period which said fee shall automatically expire on August 31, 2027.

Section 4. <u>Rates for Bulk Consumption</u>. The rates for bulk consumption as of July 1, 2019, shall be as follows: (i) Consumption Charge \$9.72 per 1000 gallons consumed.

Section 5. <u>Date Rate Change Goes into Effect</u>. The new rates shall be posted on consumers' bills for the next billing cycle, and rates shall be posted in Village Hall and on the Village website as soon as practicable. The new rates shall go into effect on July 1, 2019.

Section 6. <u>Effective Date</u>. This Resolution shall be in full force and effect from and after its passage, approval and publication in pamphlet form as provided by law.
