

RESOLUTION NO. 33-19

**A RESOLUTION APPROVING A COLLECTIVE BARGAINING AGREEMENT
BETWEEN THE VILAGE OF CHATHAM AND THE
INTERNATIONAL BROTHERHOOD OF ELECTRICAL WORKERS
LOCAL UNION NO. 51**

WHEREAS, the Village of Chatham (“Village”) is an Illinois Municipal Corporation existing and operating under the Illinois Municipal Code and the laws of the State of Illinois; and

WHEREAS, the International Brotherhood of Electrical Workers Local Union No. 51 (hereinafter “Local 51”) represents certain employees of the Village’s Electrical Department; and

WHEREAS, the Village and Local 51 have negotiated a collective bargaining agreement and the Village Board desires to approve and authorize the execution of same.

NOW THEREFORE, BE IT RESOLVED by the President and Board of Trustees of the Village of Chatham, Sangamon County, Illinois, as follows:

Section 1. Recitals. The foregoing recitals shall be and are hereby incorporated into and made a part of this Resolution as if fully set forth in this Section 1.

Section 2. Approval of Agreement. The Village Board of Trustees hereby approves the Collective Bargaining Agreement, attached hereto as Exhibit A, between the Village of Chatham and the International Brotherhood of Electrical Workers Local Union No. 51, and authorizes the Village President and Village Clerk, or Village Manager or Legal Counsel to execute same.

Section 3. Effective Date. This Resolution shall be in full force and effect from and after its passage and approval.
