A RESOLUTION ACCEPTING THE LOWEST RESPONSIBLE BIDS FOR ELECTRIC DISTRIBUTION MATERIAL NEEDED FOR 2021

WHEREAS, the Village of Chatham ("Village") is an Illinois Municipal Corporation existing and operating under the Illinois Municipal Code and the laws of the State of Illinois; and

WHEREAS, the Village of Chatham Electric Department requested bids for Electric Distribution Material needed for the year 2021; and

WHEREAS, the Village solicited bids in accordance with Illinois law for proposals from companies willing and able to provide the material requested, and the Village opened all bids on April 2, 2020; and,

WHEREAS, the bid documents made clear that the Village reserved the right to accept or reject any and/or all parts of the bid; and,

WHEREAS, the Village received lowest responsible bids for different material from two different companies, Anixter and Fletcher; and,

WHEREAS, the Village intends to accept the lowest responsible bids for material from Anixter totaling \$132,285.50 and material from Fletcher totaling \$220,758.75 as summarized in the tabulation page attached hereto as Exhibit A; and,

WHEREAS, the Board of Trustees of the Village believe it is in the best interest of the Village to accept the material bids from Anixter totaling \$132,285.50 and material bids from Fletcher totaling \$220,758.75 as attached hereto.

NOW THEREFORE, BE IT RESOLVED by the President and Board of Trustees of the Village of Chatham, Sangamon County, Illinois, as follows:

Section 1. Recitals. The foregoing recitals shall be and are hereby incorporated into and made a part of this Resolution as if fully set forth in this Section 1.

Section 2. Acceptance of Bids. The Village Board hereby approves the material bids from Anixter totaling \$132,285.50 and material bids from Fletcher totaling \$220,758.75 as attached hereto as **Exhibit A**. Any and all bids and parts thereof not explicitly approved by this Resolution are hereby rejected. The Village authorizes the Village Manager and/or Village President, or designee of either, to execute any documents necessary to complete the purchases contemplated therein.

Section 3. Effective Date. This Resolution shall be in full force and effect from and after its passage and approval.
