Section 1. <u>Recitals</u>. The foregoing recitals shall be and are hereby incorporated into and made a part of this Resolution as if fully set forth in this Section 1.

Section 2. <u>Authorization</u>. The Village Board of Trustees hereby authorizes the Village to execute the Westside Dog Park Construction and Maintenance Agreement attached hereto as **Exhibit A**. The Village President and Clerk are hereby authorized to execute the Agreement and any documents necessary to complete the transactions contemplated therein on behalf of the Village.

Section 3. Effective Date. This Resolution shall be in full force and effect from and after its passage and approval.

2. After the dog park is constructed, then the Village agrees to maintain the dog park and keep same in good repair at no charge to Friends of the Parks. The Village shall indemnify, defend, and hold harmless Friends of the Parks from and against all claims, liabilities, damages, or injury arising or resulting from the maintenance and repair of the dog park pursuant to this Construction and Maintenance Agreement.


3. This Construction and Maintenance Agreement, and the obligations and rights created hereby, are permanent and run with the land.


