

RESOLUTION NO. 48-21

**A RESOLUTION CONSENTING TO THE APPOINTMENT OF KAYLA DIERKES TO THE POSITIONS OF VILLAGE TREASURER AND CHIEF FISCAL OFFICER**

**WHEREAS**, the Village of Chatham (“Village”) is an Illinois Municipal Corporation existing and operating under the Illinois Municipal Code and the laws of the State of Illinois; and,

**WHEREAS**, pursuant to Village Code Section 31.50, the Village President is to appoint a Village Treasurer with the advice and consent of the Village Board of Trustees; and,

**WHEREAS**, the pursuant to Village Code Section 51.53, the Village President is to appoint a Chief Fiscal Officer with the advice and consent of the Village Board of Trustees; and,

**WHEREAS**, the Village’s Treasurer and Chief Fiscal Officer, Sherry Dierking, has announced that she intends to retire from the Village and resign from her position as Treasurer and Chief Fiscal Officer; and,

**WHEREAS**, the Village wishes to appoint a replacement for Sherry Dierking effective upon her resignation; and,

**WHEREAS**, the Village President has designated Kayla Dierkes as his appointee for the positions of Treasurer and Chief Fiscal Officer; and,

**WHEREAS**, the Village Board desires to approve the appointment of Kayla Dierkes to the positions of Treasurer and Chief Fiscal Officer.

**NOW THEREFORE, BE IT RESOLVED** by the President and Board of Trustees of the Village of Chatham, Sangamon County, Illinois, as follows:

**Section 1.** Recitals. The foregoing recitals shall be and are hereby incorporated into and made a part of this Resolution as if fully set forth in this Section 1.

**Section 2. Appointment.** Kayla Dierkes is hereby appointed to the positions of Treasurer and Chief Fiscal Officer of the Village of Chatham, Illinois, with the advice and consent of the Village Board of Trustees.

**Section 3. Effective Date.** This Resolution shall be in full force and effect from and after its passage and approval.
