

RESOLUTION NO. 18 - 22

A RESOLUTION AUTHORIZING SUMMER SKYZ, INC. TO OPERATE A HELICOPTER ON VILLAGE PARK PROPERTY

WHEREAS, the Village of Chatham (“Village”) is an Illinois Municipal Corporation existing and operating under the Illinois Municipal Code and the laws of the State of Illinois; and

WHEREAS, Chatham Jaycees has requested that Summer Skyz, Inc. be allowed to land and take off from Chatham Community Park on July 15, 2022 and July 16, 2022 for tours to be given during the Chatham Sweetcorn Festival; and,

WHEREAS, the Village President and Board of Trustees believe it to be in the best interest of the Village to allow for Summer Skyz to utilize the soccer fields at Village Community Park to provide tours on the dates listed herein, provided that Summer Skyz indemnify and hold harmless the Village for any and all conduct related to its operation.

NOW THEREFORE, BE IT RESOLVED by the President and Board of Trustees of the Village of Chatham, Sangamon County, Illinois, as follows:


Section 1. Recitals. The foregoing recitals shall be and are hereby incorporated into and made a part of this Resolution as if fully set forth in this Section 1.

Section 2. Approval of Use. The Village Board hereby approves and authorizes Summer Skyz, Inc. to use a designated area in Village Park for takeoff and landing of a helicopter, provided Summer Skyz, Inc. agrees to indemnify and hold the Village harmless for any conduct that occurs during the event related to its operation and to repair any and all damage caused to Village property by its operation.

Section 3. Effective Date. This Resolution shall be in full force and effect from and after its passage and approval.

The Village makes no representations as to the suitability of the proposed landing zone and makes no express or implied representations or warranties regarding the same. All take-offs, flights, and landings are conducted at Summer Skyz's own risk.

Further, Summer Skyz shall indemnify and hold harmless the Village from and against any and all claims, expenses or liabilities arising out of personal injury, death, loss or damage to property incurred by Village employees or officers, or members of the public who bring claims therefor against the Village, its employees and/or officers arising from the use of the helicopter above or upon Village property, except to the extent that if any such injury, loss, damage, or death is caused by the intentional or willful and wanton conduct of the Village, its employees of officers.

Finally, Summer Skyz agrees to repair any Village property that is damaged due to its use of a helicopter above or upon Village property at no cost to the Village.

The Village has the right to terminate the consent and authorization provided for herein with or without cause at any time.
