

RESOLUTION NO. _31_ - 22

A RESOLUTION CONSENTING TO THE APPOINTMENT OF CERTAIN BOARD AND COMMITTEE MEMBERS

WHEREAS, the Village of Chatham (“Village”) is an Illinois Municipal Corporation existing and operating under the Illinois Municipal Code and the laws of the State of Illinois; and

WHEREAS, pursuant to Section 32.42 of the Village Code, the Village President has the authority to appoint members to the Board of Fire and Police Commissioners with consent of the Village Board; and,

WHEREAS, pursuant to Section 158.111 and 158.112 of the Village Code, members of the Planning Commission shall be appointed by the Village President with advice and consent of the Village Board; and,

WHEREAS, pursuant to Section 158.117 of the Village Code, appointments to the Zoning Board of Appeals shall be made by the Village President subject to approval of the Village Board; and,

WHEREAS, several Village Boards and Commissions need to appoint members for the upcoming terms and accept resignations of other members; and,

WHEREAS, the Village President has recommended the following:

- Reappoint Jared Koester to the Board of Fire and Police Commissioners for the term ending April 30, 2025
- Reappoint Todd Johnson to the Zoning Board of Appeals for the term ending April 30, 2027
- Reappoint Brian Stenke to the Zoning Board of Appeals for the term ending April 30, 2027
- Reappoint Jason Jones to the Planning Commission for the term ending April 30, 2028
- Reappoint Jane Hay to the Planning Commission for the term ending April 30, 2028
- Reappoint John Moore to the Planning Commission for the term ending April 30, 2028

- Appoint Dan Lewis to the Planning Commission for the term ending April 30, 2024

WHEREAS, the Village Board believes it to be in the best interest of the Village to accept and consent to the appointments and reappointments as recommended by the Village President.

NOW THEREFORE, BE IT RESOLVED by the President and Board of Trustees of the Village of Chatham, Sangamon County, Illinois, as follows:

Section 1. Recitals. The foregoing recitals shall be and are hereby incorporated into and made a part of this Resolution as if fully set forth in this Section 1.

Section 2. Appointment of New Board Members and Commissioners. The Village Board of Trustees hereby accepts and consents to the appointments of the following:

- Reappoint Jane Hay to the Planning Commission for the term ending April 30, 2028
- Reappoint John Moore to the Planning Commission for the term ending April 30, 2028
- Appoint Dan Lewis to the Planning Commission for the term ending April 30, 2024
