#### A RESOLUTION APPROVING THE PURCHASE OF A NEW 2022 TRUVAC VACUUM EXCAVATOR AND 2022 VACTOR MANUFACTURING TRAILER-MOUNTED JETTER

WHEREAS, the Village of Chatham ("Village") is an Illinois Municipal Corporation existing and operating under the Illinois Municipal Code and the laws of the State of Illinois; and

WHEREAS, in April, 2022, the Village approved the sale and leaseback of its 2018 Vactor pending the construction and outfitting of a new Vactor by Coe Equipment, Inc. acquired through Sourcewell; and,

WHEREAS, Coe Equipment, Inc. is now able to provide the Village with a new Truvac Vacuum Excavator for \$404,536.69 pursuant to the invoice attached as **Exhibit A**, and a new 2022 Vactor Trailer-Mounted Jetter for \$80,976.69 pursuant to the invoice attached hereto as **Exhibit B**; and,

WHEREAS, the Village intends to finance the Truvac Vacuum Excavator and present bids for financing to the Board at its November 8, 2022, meeting; and,

WHEREAS, the Village intends to pay for the Vactor Trailer-Mounted Jetter in full without financing; and,

WHEREAS, the Village Board of Trustees has determined it to be in the best interest of the Village to purchase the equipment as set forth herein.

**NOW THEREFORE, BE IT RESOLVED** by the President and Board of Trustees of the Village of Chatham, Sangamon County, Illinois, as follows:

Section 1. <u>Recitals</u>. The foregoing recitals shall be and are hereby incorporated into and made a part of this Resolution as if fully set forth in this Section 1.

**Section 2.** <u>Approval of Purchase</u>. The Village Board of Trustees hereby approves the purchase of the Truvac Vacuum Excavator as set forth in the invoice attached hereto as **Exhibit** 

A, and the 2022 Vactor Trailer-Mounted Jetter as set forth in the invoice attached hereto as **Exhibit B**.

Section 3. Effective Date. This Resolution shall be in full force and effect from and after its passage and approval.
