#### **RESOLUTION NO. 33-24**

#### A RESOLUTION APPROVING THE PURCHASE OF PICKLEBALL NET SYSTEMS

WHEREAS, the Village of Chatham ("Village") is an Illinois Municipal Corporation existing and operating under the Illinois Municipal Code and the laws of the State of Illinois; and WHEREAS, the Village requested quotes for the purchase of portable pickleball net systems; and

WHEREAS, the Village received three quotes for the purchase of 16 premiere portable pickleball net systems; (1) On Court Off Court Game Changers for \$37,437.20; (2) Douglas Sports Equipment for \$38,919.20; and (3) Putterman Athletics for \$40,847.52 plus shipping; and,

WHEREAS, the Village intends to accept the low quote for 16 premiere portable pickleball net systems from On Court Off Court Game Changers in the amount of \$37,437.20 as further described in the attached hereto as Exhibit A; and,

WHEREAS, the Village has budgeted enough American Rescue Plan Act (ARPA) funds for the purchase the 16 premiere portable pickleball net systems; and,

WHEREAS, the Board of Trustees of the Village believe it is in the best interest of the Village to accept the quote from On Court Off Court game Changes as attached hereto;

**NOW THEREFORE, BE IT RESOLVED** by the President and Board of Trustees of the Village of Chatham, Sangamon County, Illinois, as follows:

- Section 1. Recitals. The foregoing recitals shall be and are hereby incorporated into and made a part of this Resolution as if fully set forth in this Section 1.
- Section 2. Acceptance of Quote. The Village hereby accepts the low quote from On Court Off Court Game Changers for the purchase of 16 premiere portable pickleball net systems in the amount of \$37,437.20, all as further described in the attached **Exhibit A**. Any and

all quotes and parts thereof not explicitly approved by this Ordinance are hereby rejected.

The Village authorizes the Village Manager and/or Village President, or designee of either, to execute any documents necessary to complete the purchases contemplated therein.

**Section 3**. Severability. In the event a court of competent jurisdiction finds this ordinance or any provision hereof to be invalid or unenforceable as applied, such finding shall not affect the validity of the remaining provisions of this Resolution and the application thereof to the greatest extent permitted by law.

Section 4. Repeal and Savings Clause. All resolutions or parts of resolutions in conflict herewith are hereby repealed; provided, however, that nothing herein contained shall affect any rights, actions, or causes of action which shall have accrued to the Village of Chatham prior to the effective date of this Resolution.

Section 5. Effective Date. This Resolution shall be in full force and effect from and after its passage and approval.


