Trustee Schatteman moved, seconded by Trustee Kimsey, to bring to the table Ordinance 14-31, An Ordinance Approving the Engagement of Estes Bridgewater & Ogden for Audit Services for Fiscal Years 2014, 2015 and 2016.

Trustee Boyle moved, seconded by Trustee Schatteman, to make name and date corrections in the body of the ordinance. **The motion to amend passed by voice vote**.

Explained by title, at a cost of \$23,700 per year, ordinance 14-31, as amended, passed by roll call vote 6 yes, 0 no, 0 absent as follows: Clayton, yes; Kimsey, yes; Boyle, yes; Holden, yes; Formea, yes; and Schatteman, yes.

Trustee Holden moved, seconded by Trustee Formea, to bring to the table Ordinance 14-32, An Ordinance Approving a Lease Purchase Agreement with Bank and Trust Company. This ordinance approves the lease purchase of a Caterpillar 420E Backhoe Loader in the amount of \$70,000 amortized over three years at an interest rate of 1.34% with an option to purchase the vehicle at the conclusion of the lease for nominal consideration.
