Public Safety, chair Boyle with Holden and Kavanagh; Administrative Committee, chair Kavanagh with Boyle and Kimsey; Public Properties, chair Schatteman with Kimsey and Clayton; Public Works and Utilities, chair Holden with Clayton and Schatteman. 13-16 passed by roll call vote 6 yes, 0 no, 0 absent as follows: Clayton-yes, Kimsey-yes, Boyle-yes, Holden-yes, Kavanagh–yes, Schatteman-yes.

Trustee Schatteman moved, seconded by Trustee Holden, to bring to the table **Ordinance 13-17, An Ordinance Accepting a Bid for Tennis Court Overlay.** A bid of \$46,800 from All Weather Courts to repair and resurface tennis courts was accepted.
