### G. CLERK'S REPORT

Filing for the 2011 Non-partisan Consolidated Primary Election is November 15-22, 2010. The Primary is February 22, 2011. Three Trustee seats will be contested: Boyle, Reynolds, and Kavanagh. A Primary is required when more than 12 candidates file for trustee. The Consolidate Election is April 5, 2011.

### H. OLD BUSINESS

There was no action on an **Ordinance Abating an Alley**. It will remain an old business item until acted upon or removed.

### I. NEW BUSINESS

Trustee Herr moved, seconded by Trustee Kavanagh, to bring to the table Ordinance 10-54, An Ordinance Accepting a Bid Proposal for Installing Water Main for Phase 2 & New Berlin of the Transmission Main Project. The village obtained proposals for installation of eighteen and ten inch water mains for what is referred to as Phase 2 and New Berlin respectively in the water main transmission project to install a water main from the water plant to New Berlin. Phase 2 begins near Ball Elementary and extends east to Pawnee Road and the New Berlin phase begins at Wesley Chapel Road and extends west on Mansion Road. The Public Works Committee recommended a proposal from Petersburg Plumbing for Phase 2 for an estimated cost not to exceed \$150,000 and from McIntire & Company for the New Berlin phase for an estimated cost not to exceed \$250,000, both billed at an hourly cost for labor and material. 10-54 passed by roll call vote 5 yes, 1 no, 0 absent as follows: Herr - yes, Mau - no, Boyle - yes, Reynolds - yes, Kavanagh - yes, and Schatteman - yes.

### J. CALENDAR OF EVENTS
